## GENERAL REGULATION

### 1) DEFINITION AND APPLICATION

This regulation applies to the event called 64º Cage and Aviary Bird World Show – Matosinhos 2016, organised by the Federação Ornitológica Nacional Portuguesa-FONP, under coordination and supervision of the COM-Confédération Ornithologique Mondiale. This competition is ruled by this general regulation and by the OMJ and COM regulations, which are considered included in this regulation.

### 2) VENUE

The event will be held in halls 5 and 6 of EXPONOR, in Matosinhos:

### 3) ORGANISATION AND MANAGEMENT

#### Honorary Committee

The honorary Committee will be composed of members of the worldwide and national ornithological entities, of the COM, official representatives and other guests. It constitutes the institutional reference of the event.

#### Organising Committee

It is composed by the members of the Committees of FONP, its partners of FOP and COM-Portugal and other invited members.

#### Jury

The jury will be composed of Portuguese and foreign OMJ international judges

#### Control Committee and COM Supervision

The control committee will be responsible for assuring the regularity of the competition and ring control of the medal winners and it will be composed by designation of the COM.

### 4) ENTRIES FROM BREEDERS

Entries will be accepted from breeders affiliated to any COM national entity. All breeders must enter their "national breeder number(s)" and they authorize the organising committee and the COM to do all procedures considered necessary to check this information. All breeders entering birds declare that their exclusive objective in participating is purely amateur and only with recreational purposes.

With their entry, each breeder declares that he has taken notice and agrees with this general regulation and renounces totally to any right of compensation resulting from classification, disqualifications, suspensions, or exclusions obtained, theft or death of any bird and also declares to accept any decision taken by the jury or the Control Committee, for all effects previewed by the Portuguese law.

All breeders entering birds authorize the Organising Committee or its delegates to manipulate birds for the purpose of ring control, photographing or filming. The eventual rights or products of these photos and films belong to the COM. They also authorize the sharing of all their personal data between the organizers, FONP, COM-Portugal and COM for all effects related to the World Show.

### 5) OISEAUX INSCRITS

All birds to be admitted in the show must have been born and raised in domestic environment and bred by the entrant and carrying an official ring recognized by a federation affiliated to a COM national entity.

### 6) INSCRIPTION AND BIRD ENTRY

Entering birds will only be admitted using the COM section and class list annexed to this regulation.

The entries will be validated when entered using the official chart and paid (12,00 Euros per bird for the Portuguese breeders, for foreign breeders the fee will be determined by their COM National Entity according to their expenses of transport, managing, certification etc.). Entries must be entered by the breeder's COM National Entities and according to their rules and procedures. With their entry, each breeder should also pay 12,00 supplementary Euros for the official catalogue and award sheet.

The deadline for the entering of birds is set to 15 December 2015. Entries should be registered by the National Entities by the online registering system set up by the Secretariat of the Organizing committee, together with the proof of payment by bank transfer to the following account:

The access to the system will be ready to accept entries from the 15 of November 2015. Each country coordinator will receive a password.

## 7) SANITARY CERTIFICATION AND RESPECT OF OFFICIAL REGULATIONS

All birds entered subject to the CITES regulations should arrive with the proper certification titles and the European Birds entered should comply with all the regulation applicable to each species.

UE Countries: For these countries a veterinary certificate should be presented, signed by the responsible veterinarian of origin.

NON-UE Countries: The participation of these countries is conditioned to the appreciation of the General Veterinarian Direction of Portugal and the presentation of special documentation and therefore the responsables of the corresponding National Entities should contact the Organising Committee for special information.

All the birds participating in the show should be transported with quality and in observation of the animal well being. The transport cages should be adequate and food and water should be planned and available. Countries that want to use the airplane should warn the Organising Committee of day and time of arrival and flight numbers.

## 8) CAGING OF THE BIRDS AND CONVOYEURS

The foreign convoyeurs will be received and hosted from 18h of Friday 15<sup>th</sup> of January 2016. Caging of foreign birds will be held Saturday 17<sup>th</sup> of January 2016. Portuguese birds will be caged Sunday the 17<sup>th</sup> of January 2016 from 9 to 12 h and from 14 to 18h, directly by the breeders or by the national convoyeurs.

For the Portuguese breeders, a free transport of their birds will be organised by COM-Portugal, with reception centres in Algarve, Almada, Portalegre, Castanheira do Ribatejo, Peniche and Figueira da Foz. Breeders wanting to use this service should contact the Organising Committee.

Before caging, all birds will be checked for sanitary reasons and caging will be refused to all birds considered non compliant. Before caging, water and food (seed or other) will immediately be made available for the birds.

**It is absolutely forbidden to cage a bird without availability of food and water.**

From January 17 the convoyeurs will be available to the Organising Committee for the judging operations and caring of the birds in the show.

## 10) MEDALS AND AWARDS FOR THE WINNERS

The following titles will be awarded to first three birds/teams in each class, with a minimum classification of:

Minimum points	Gold medal	Silver medal	Bronze medal
Single Classes	90	90	90
Team Classes	360	360	360

The medals to be awarded will be of metal resembling gold, silver and bronze. Each breeder will receive a participation diploma, a special diploma for each world champion and a personal diploma with all the medals won.

## 12) TAKE-OUT OF THE BIRDS

The take-out of the Portuguese birds will be done from 18h of Sunday the 24th of January 2016, followed by the take-out of the foreign birds that can also continue Monday the 25<sup>th</sup> of January 2016.

The take-out of the Portuguese birds will be organised by order of inscription – number given when entering the birds in the show. The Organising Committee will try to proceed to the take-out of the birds quickly and with priority to those travelling long distances or to those organised by clubs, and therefore we ask all the understanding of all breeders regarding this procedure.

## 13) CLOSING

The Show will be considered closed after the take-out of all birds.

## 14) OMISSIONS AND NON PREVIEWED CASES

In all situations non-previewed by the regulations, the COM will rule, in cooperation with the Organising Committee for all logistic subjects and in respect of the Portuguese law.
